The People's Republic of Bangladesh has received financing from the Asian Development Bank (ADB) and the Asian Infrastructure Investment Bank (AIIB) towards the cost of Natural Gas Infrastructure and Efficiency Improvement Project, and it intends to apply part of the proceeds of this financing to payments under the above loans. Bidding is open to Bidders from eligible source countries as defined in Section 5 of the bidding documents.
2. Bangladesh Gas Fields Company Limited (BGFCL) ("the Employer"), a Company of Bangladesh Oil, Gas & Mineral Corporation (Petrobangla) invites sealed bids from eligible bidders for Procurement of design, engineering, supply, installation, testing, commissioning and operation of 07 nos. of Wellhead Compressors (each having capacity of 60 MMSCFD) with associated equipment & facilities at Location-A of Titas Gas Field ("the Facilities").
3. **Qualification Criteria for Bidders:**
  - **General Experience:** The bidder must have experience of Participation as an EPC contractor, JV partner, or subcontractor covering Engineering, Procurement, Construction & Commissioning basis in at least two contracts for Compressor, one of which has been successfully completed and one substantially completed within the last ten (10) years, counting backward from the date of bid submission, and that are similar to the proposed contract, where the value of the Bidder's (or JV partner) participation under each contract exceeds US\$ 53 (fifty three) million. Both contracts should be executed outside Bidders' home country.
  - **Specific Experience:** The bidder must have minimum experience of Supply, Installation, Testing and Commissioning of successfully completed at least one contract of natural gas compressor station with minimum one compressor having rated power of not less than 2000 BHP outside their home country.
  - **Average Annual Turnover:** The minimum average annual turnover shall be US\$ 53 (fifty three) million within the last 3(three) years.
  - **Historical Financial Performance:** The bidder shall submit at least last 3(three) year's audited financial statements for this purpose. As a minimum, the Bidder's net worth for the last year should be positive.
4. International competitive bidding will be conducted in accordance with ADB's Single-Stage: Two-Envelope procedure and is open to all bidders from eligible countries as described in the Bidding Document.
