

Experience, Resources and Delivery Capacity Required	The interested firms must meet the following minimum criteria for short listing: a) The valuer firm must be registered with the Institute of Chartered Accountants of Bangladesh (ICAB). b) The firms shall have minimum 5 (Five) years of general experience. Firms having experience in similar assignments will get preference. c) The firms should have provisions of Chartered Accountant, Graduate Engineers (Electrical, Mechanical, Civil), Valuer, Surveyor etc, to carry out the proposed consultancy and valuation services. d) The firm(s) must submit updated Income Tax Certificate (2020-2021), Last three year's Audit Reports, BIN, Bank solvency Certificate and valid documents of relevant working experience. e) The valuer firm must be enlisted with Bangladesh Securities & Exchange Commission (BSEC) as Valuer. As per Revaluation Rules of Ministry of Finance, the External Audit firms of BGFCL in preceding three years are not eligible to participate in this EOI.
