			 Under the project, a contract was signed with EPC contractor Consortium of Zicom Equipment Pte. Ltd. Singapore & AG Equipment Company, USA on 12.10.2022 at a total cost of Tk 409,80,98,808.00 including foreign currency USD 4,38,33,778.00 & local currency Tk 32,83,93,900.00. Under the contract, EPC contractor was not able to establish a confirmed Letter of Credit (LC) in favor of Beneficiary Zicom Equipment Pte. Ltd. Singapore. Consequently BGFCL contacted with other foreign banks in Bangladesh such as Standard Chartered Bank (SCB), Citibank N A, Bank Alfalah Limited, State Bank of India (SBI) and The Hongkong and Shanghai Banking Corporation Limited (HSBC) as per decission of PSC meeting held on 18.05.2023. Among the aforesaid banks, Standard Chartered Bank (SCB) and State Bank of India (SBI) sent proposals mentioning the cash margin amount, cost and conditions for establishment of LC. A decision was taken to establish LC of USD 4,38,33,778.00 in favor of Zicom Equipment Pte. Ltd. Singapore in SCB upon encashment of 105% margin at the 704th BGFCL board meeting held on 10.07.2023. As per decision of the board meeting, BGFCL and SCB, Dhaka on 16.08.2023 and another meeting was held among the representatives of BGFCL, SCB & Zicom on 30.08.2023. SCB informed the representatives of BGFCL, SCB & Zicom on 30.08.2023. SCB informed the representatives of BGFCL that SCB's CB's ESRM (Environmental & Social Risk Management) Team in Poland provided environmental clearance on 15.08.2023 to open the LC including some recommendations on environmental issues. SCB is in the process of Internal Approval of Credit Limit to issue the LC of USD 4,38,33,778.00.
